In compliance of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. CIR/CFD/CMD/4/2015 dated 9th September, 2015, we would like to inform you that the Company on 6th July, 2023 acquired by way of allotment on preferential issue basis 20,00,00,000 (Twenty Crore)- 0.0001% Compulsorily Convertible Preference Shares of the face value of Rs. 10/- each ("CCPS") of Inox Green Energy Services Limited, subsidiary company, upon variation of the terms of 20,00,000 - 0.01% Non-Convertible, Non-Cumulative, Participating, Redeemable Preference Shares of the face value of Rs. 10/- each ("NCPRPS") held by the Company.

These 20,00,000 (Twenty Crore) CCPS allotted on variation of the terms of NCPRPS shall get converted into 4,16,66,666 (Four Crore Sixteen Lakh Sixty Six Thousand Six Hundred Sixty Six) fully paid up equity shares of face value of Rs. 10/- each of Inox Green Energy Services Limited ("Equity Shares"), at a price of Rs. 48/- (Rupees Forty Eight only) per Equity Share (including a premium of Rs. 38/- (Rupees Thirty Eight only) for each CCPS ('Conversion Price'), upon exercise of conversion from time to time, in one or more tranches, within a maximum period not exceeding 18 (Eighteen) months from the date of allotment of CCPS. Post the full conversion of CCPS, the shareholding of the Company in IGESL shall increase from existing 56.04% to 61.23%.
